## LEWIS AND CLARK RADI0 CLUB, INC.

## CONSTITUTION

## PREAMBLE

We, the undersigned, wishing to secure for ourselves and others the pleasures and benefits of the association of persons commonly interested in Amateur Radio, constitute ourselves the LEWIS AND CLARK RADIO CLUB, INC., and enact this constitution as our governing law.
It shall be our purpose to promote and encourage Amateur Radio as a hobby; to promote and further the exchange of information and co-operation to further radio knowledge, fraternalism, and individual operating efficiency; to coordinate the activities of individuals and Amateur Radio Clubs; to foster the civic, educational, fraternal, disaster aid, and social aspects of Amateur Radio; to conduct club programs and activities to advance the general interest and welfare of Amateur Radio in the community; and to exercise all such powers enumerated in the GENERAL NOT FOR PROFIT CORPORATION ACT of the State of Illinois.

## ARTICLE I (MEMBERSHIP)

All persons interested in amateur radio communication shall be entitled to apply for membership. Membership shall be by application and election upon such terms as the club shall by its by-laws provide.

## ARTICLE II (OFFICERS)

Sec. 1 -- (amended 4 Jan 00) The officers of this club shall be: PRESIDENT, VICE-PRESIDENT, SECRETARY, TREASURER, DIRECTOR, and CORPORATE TRUSTEE, and said officers shall constitute the Board of Directors.

Sec. 2 -- The officers of this club shall be elected for a term of two year and director for one year by ballot of the members present, providing there shall be a quorum. Nominations for officers will be made at the October meeting and nominees must have reached the age of 18 years and be a member in good standing. Elections for officers will be held at the November meeting. The officers elected will assume office beginning with the January meeting following election. Election shall be by simple majority. The corporate trustee is appointed by the Board of Directors and will serve continuously until such time he/she is removed by three-fourths vote of the Board of Directors.

Sec. 3 -- Vacancies occurring between elections must be filled by special elections at the first regular meeting following the withdrawal or resignation, providing there is a quorum present.

Sec. 4 -- Officers may be removed by a three-fourths vote of the membership present at the first meeting after notification by mail of the pending election or removal.

## ARTICLE III (DUTIES OF OFFICERS)

Sec. 1 -- The President shall preside at all meetings of this club, and conduct the same according to the rules adopted. He or she shall enforce due observance of this constitution and by-laws, decide all questions of order, sign all official documents that are adopted by the club, and none other, and perform all other customary duties pertaining to the office of president, and such others as may be prescribed by the by-laws or that may be assigned by the Board of Directors.

Sec. 2 -- The Vice-President shall assume and perform all duties of the President in the absence of the latter, and such other duties as may be assigned by the President or the Board of Directors.

Sec. 3 -- The Secretary shall keep a record of the proceedings of all meetings, keep a roll of members, submit applications for membership, carry on all correspondence, and read communications at each meeting when necessary. He or she shall at the expiration of his or her term turn over all such records and items to his or her successor. The Secretary shall perform such other duties as may be presented by the by-laws or that may be assigned by the President or the Board of Directors.

Sec. 4 -- The Treasurer shall receive and receipt for all monies paid to the club, and shall keep an accurate account of all monies received and expended. No bills shall be paid without proper authorization by the club or its officers constituting a business committee. At each meeting the Treasurer shall submit a treasurer's report of disbursements and receipts, bills to be paid, and the balance on hand, and shall at the expiration of his or her term turn over all such records, monies and items to his or her successor. The Treasurer shall perform such other duties as may be prescribed by the by-laws or that may be assigned by the President or the Board of Directors.

Sec. 5 -- The Corporate Trustee shall have all duties and responsibilities required by the State of Illinois pertaining to the Corporation and shall be responsible to pay the corporate fees each year as required by law. He shall also perform other duties as a director of the corporation as set forth in Article III, Sec. 2 (F) of the By-Laws.

Sec . 6 -- (amended 4 Jan 00) The Director shall perform such other duties as may be presented by the by-laws or that may be assigned by the President or the Board of Directors.

ARTICLE IV (MEETINGS)
The by-laws shall provide for regular and special meetings. At meetings a minimum of twenty percent of the membership shall constitute a quorum for the transaction of business.

## ARTICLE V (DUES AND MEMBER EXPULSION)

The club, by majority vote of those present at any regular meeting may levy upon the membership such dues as shall be deemed necessary for the business of the organization within its objects as set forth in the preamble. Non-payment of such dues shall be cause for expulsion from the club within the discretion of the membership. Other causes for expulsion may be adopted and approved from time to time by the Board of Directors and notice thereof shall be given to the membership.

## ARTICLE VI (AMENDMENTS)

This Constitution may be amended by a minimum of two-thirds vote of the members present. Proposals for amendments shall be submitted in writing at a regular meeting and shall be voted upon at the next following regular meeting, provided all members have been notified by mail of the intent to amend the constitution at said meeting.

## ARTICLE VII (RULES OF ORDER)

Robert's Rules of Order shall govern proceedings and all questions not otherwise specified in this Constitution or the by-laws.

## ARTICLE VIII (EFFECTIVE DATE)

This Constitution shall be effective immediately upon adoption by the membership at a regular or special meeting with prior notice having been given to the membership.

The foregoing Constitution of the LEWIS AND CLARK RADIO CLUB, INC. was adopted by the membership at their meeting with prior notice having been given to the membership, said adoption having occurred on this 17 th day of May, 1987., and amended this $4^{\text {th }}$ day of January 2000.
